## Instructions

- If you do not have, or will not have, qualified higher education expenses at an Eligible Educational Institution<sup>1</sup>, you can irrevocably forfeit funds in your CalKIDS Account at any time by completing this form and submitting it to CalKIDS. Forfeited funds will be transferred to the State of California. **Once funds are forfeited, they cannot be used by you for any purpose.**
- You are under no obligation to forfeit funds. Funds will automatically be forfeited if they are not disbursed to an Eligible Educational Institution before you turn 26 years of age.
- **Do not use this form to withdraw funds to pay any qualified higher education expenses.** Visit **CalKIDS.org** to request payment directly to an Eligible Educational Institution.
- You must provide all the requested information and your signature on this form.

Qualified Higher Education Expenses are tuition and fees; costs of books, supplies and equipment required for the enrollment or attendance, and certain amounts for room and board.
